

All efforts will be made to assist you in meeting the 60-day requirement. Should you decide to keep your product after obtaining RGA authorization, please advise us by calling the number listed above. We will cancel your authorization.

When returning product that is not defective, damaged, or a United Spirit of America shipping error, the following terms and conditions apply, (a) items must be received in unopened cases with original packaging intact, (b) items with "piggyback labels" will not be accepted (these fall into the made to order category), (c) items not in salable condition due to improper storage, spoilage, expired date or damaged packaging are not returnable.
