1. SYSTEM OVERVIEW

PMK Essentials

The **Preventive Medicine Kit (PMK) Essentials** is a compact, Soldier-level preventive medicine capability designed to mitigate the most common **Disease and Non-Battle Injury (DNBI)** drivers encountered during field training and operational deployments.

The system focuses on **environmental injury prevention, vector exposure reduction, foot health preservation, and basic hygiene sustainment** in austere environments.

PMK Plus

The **Preventive Medicine Kit Plus (PMK Plus)** is an expanded, standardized preventive medicine system that builds upon PMK Essentials by incorporating **communicable disease control, tissue protection, and musculoskeletal sustainment**.

PMK Plus is intended for **extended-duration operations**, high-risk DNBI environments, and units requiring a more comprehensive Soldier survivability solution.

2. INTENDED OPERATIONAL USE

Both PMK variants are designed for:

- Initial Entry Training (IET / OSUT)
- Unit field training exercises (FTX)
- Pre-deployment preparation
- Deployed operations
- High-UV, high-heat, high-humidity, and vector-dense environments

Use is **preventive, continuous, and Soldier-managed**.
